NON-PROFIT FILINGS

- IRS and Secretary of State filed by Treasurer Lauren Patterson in February 2023.
- Lauren received Tax Exemption letter from Tennessee Department of Revenue that is valid until June 30, 2027. We can present this to vendors to receive tax-exempt status.

- Board briefly discussed a few options (Reign Event Venue, Germantown Great Hall, Botanic Garden). Rob mentioned that the reason we moved the conference away from the Botanic Garden was because they limit our catering options to their approved list of caterers.
- Committee will meet this week and make a decision by end of next week

SPRING STUDENT SCHOLARSHIP EVENT

- This event will replace the scholarship competition that used to take place during the annual conference. It will include a scholarship competition and a panel discussion, plus potentially other activities. (Map Gallery contest?)
- We still need to name the event. The most popular ideas from the December meeting were:
 - MAGIC Student Symposium
 - MAGIC Student Showcase
- The first priority is to book a date and venue so we can announce.
 - o Alysssa talked to Dr. Arleen Hill, who suggested Friday 4/5 or Friday 4/12 after 2 PM
 - The date we have to avoid is Earth Day (Monday 4/22)
 - Shawn pointed out that TNGIC Conference is 4/9 4/11, so 4/12 not a good idea
 - Lee indicated he would prefer that the event start at 1 PM.
 - Alyssa will check with Dr. Hill to see if Friday 4/19 at 1 PM would work
 - o Dr. Hill told Alyssa that we can use Johnson Hall for free if a student organization books it, but there would be a charge if MAGIC books it.
 - Alyssa will check with Dr. Hill to see if the Earth Science Club could book Johnson Hall on behalf of or in partnership with MAGIC. (She is secretary of the club.)
